**Inter-Agency Working Group for Specialized Nutritious Food Products
11th Annual Meeting Communiqué
Monday, September 10th-Tuesday, September 11th, 2018
Brussels, Belgium**

Goal of the Inter-Agency Working Group: The overarching goal of the International Inter-Agency Group for Specialized Nutritious Food Products (SNFPs) is to promote appropriate formulations, modifications, and use of specialized nutrition food products in a manner that complies with international standards and is consistent with guidance from normative bodies on nutritional value and food safety, also taking into account advances in science, including product related research and development, operational needs of agencies, and empirical understanding of costs and effectiveness. (Inter-Agency Working Group for Specialized Nutritious Food Products Terms of Reference, October 2016)

The purpose of this document is to share the main topics discussed, points of agreement, and future priority actions that resulted from the 11th Inter-Agency Working Group for Specialized Nutritious Food Products. (held September 10th and 11th, 2018 at the Médecins Sans Frontières (MSF) Office, Brussels, Belgium)

Key Topics Discussed

The key topics discussed during the meeting were: (a) Accomplishments since the June 2017 meeting; (b) updates on the harmonized ready-to-use food (RUF) specifications; (c) new formulations of “next generation” RUFs; (d) updates on recent Codex and World Health Organization (WHO) activities relevant to specialized nutritious food products; (e) applications for two new member organizations to the inter-agency working group; (f) programming considerations and research related to SNFPs; (g) food safety and quality including storage and transport practices, joint inspection and auditing; (h) drafting of inter-agency talking points related to inclusion of SNFPs on the essential medicines list (EML).

Major Outcomes

- Accepted International Committee of the Red Cross (ICRC) and Action Against Hunger (ACF) as new members of the Inter-Agency Working Group.
- Agreed to no longer pursue a harmonized premix across all LNS products due to the inability to use the same premix in SQ LNS that is used in larger LNS products due to organoleptic changes it causes.
- Identified a need for Inter-Agency alignment on recommendations on the level and type of evidence needed for adaptations to current SNFs and new SNF formulations.
- Prioritized the need for continued harmonization regarding packaging and moving toward 1) improved integrity, 2) exploring sizing/demarcation etc. that corresponds with programming protocols, practices, and operational needs 3) reducing environmental impact
- Shared specifications for High-Energy Biscuits 2.0, for harmonization.
- Identified the need for harmonized dosing and ration guidance documents for SNFPs.
- Recognized the need to define a system for feedback from on field incidents and challenges to the Inter-Agency Working Group and for the Working Group to communicate back down to field that is aligned with the work of other global groups and platforms engaged in nutrition and humanitarian response.

Priority Areas for Inter-Agency Work in the Next Year

Points for Ongoing Discussion/Consideration

Workstream 2: Operations (Programming and Protocols) and Research

- Develop a system for receiving feedback from field on incidents and challenges to the Inter-Agency Working group and communicating solutions back to the field
 - Define issues that would be brought to this working group and stakeholders to be involved
 - Develop the roadmap from problem definition, solution and communications back to implementation solution, document the recent HEB process for informing the roadmap
 - Summarize updated evidence regarding dosing
 - Continue to discuss programming for pregnant and lactating women (PLWs)
 - Share Inter-Agency working group activities at the No Wasted Lives (NWL) meeting on November 13th and 14th
 - Define an agenda for future interactions with NWL and determine what activities fall within the mandate of the Inter-Agency Working Group compared to NWL
 - WFP to share a brochure regarding nutrition research priorities to gauge interest among other inter-agency members
 - Facilitate discussion on research priorities as needed, aggregate information on emerging research priorities
 - Continue to discuss waste management of SNFP packaging as a programming priority
- HEB 2.0 protocol for use and use of HEB versus Emergency Ration
 - Strategies to ensure changes to SNFPs address problems being reported from the field
 - This may include developing pre-requisites for field testing new formulas and developing a standardized methodology
 - Collecting experiences on programming for PLWs
 - No Wasted Lives research priorities and synergies with the Inter-Agency group
 - Share results of a number of ongoing studies that will provide more information on the optimal dosing requirements for the most effective and cost-effective options for treating acute malnutrition.
 - Share results from ongoing studies on the effectiveness of “combined/integrated” protocols for addressing SAM and MAM using one product at different doses and MUAC measurement for enter and discharge
